Our *free* MAP Alert email service provides reminders about the more than 40 endorsed insurance, financial, legal, and discount plans available to NYSUT members. This service is a great way to learn about these programs and become acquainted with Member Benefits!

MAP Alert messages are usually sent once every three weeks. Members have the option of reading a brief text message or viewing it in a visually pleasing webpage format.

A MAP Alert may be an advance notice of a change in an existing plan, advance notice of a new endorsement or simply a reminder about a program. We will also ask for your opinion at times -- helping us determine potential new endorsements.

Another bonus to joining MAP is the opportunity to win valuable prizes. Each quarter, one MAP winner is randomly selected.

To sign up for MAP, simply complete the brief sign-up form on the Member Benefits website at [memberbenefits.nysut.org](http://memberbenefits.nysut.org), and within three weeks, you'll begin to receive MAP Alerts.

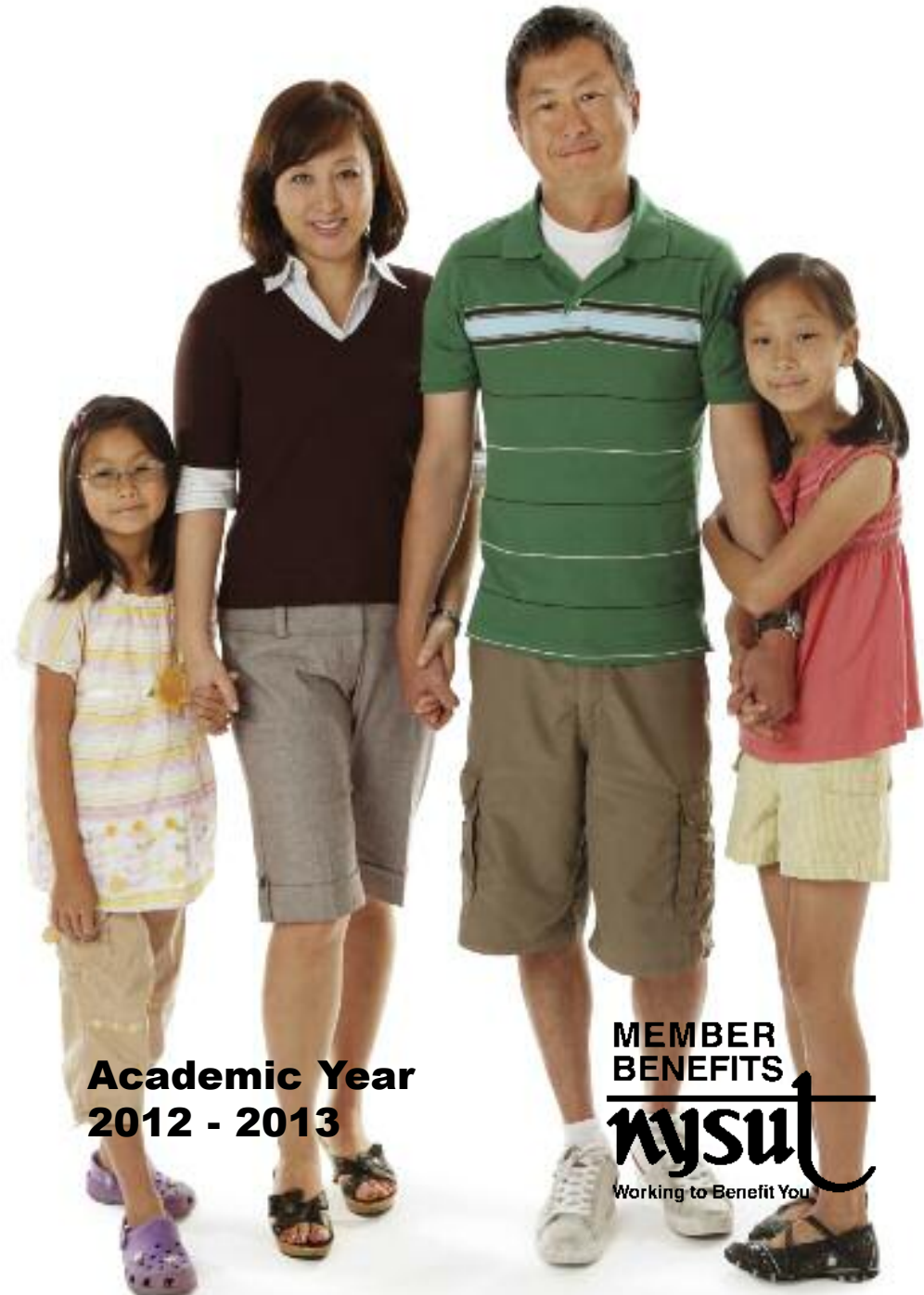

New Member Welcome Flyer**

As a new NYSUT member, you will receive a special welcome flyer from NYSUT Member Benefits upon our receipt of new member enrollment information from your local association. The flyer will be sent to your home address and include:



- An offer to participate in the **New Member Legal Service Plan** for a six-month trial period. Enrollment in the program is provided at no cost to you. There is no obligation to enroll in the Legal Service Plan at the conclusion of the six-month plan.
- Information about the many **discount programs** in place for NYSUT members.
- Provision of a no-cost **Term Life Insurance policy providing coverage for up to \$25,000** for one year, as long as NYSUT membership is maintained through your local. You do not need to complete any paperwork to receive this free coverage. The actual Certificate of Insurance will be sent to you by Marsh U.S. Consumer -- the plan administrator -- once it has the necessary information to issue a certificate. The insurance is guaranteed renewable for up to \$25,000 at the end of the year with no medical underwriting. As always, there is no obligation for you to renew the policy upon the end of the free year. (Please note that there is no term life insurance benefit provided to new members age 85 or older.)

Also, under separate cover, you'll receive **an offer to apply for up to \$1,500 in monthly disability benefits** without review of your medical or health status to determine if you qualify for coverage. This special new member offer will be available for a limited time period. New members must be age 64 or younger and be working 20 hours a week or more to qualify.

For purposes of these offers, a new member is considered to be anyone -- including an agency fee payer -- who has never been a member of or agency fee payer to NYSUT in the past. Transfers from one local association to another will not be considered new members.
